GL 10-7-1

Guidelines for Treatment of Prohibited Activities

and Objects on the Exhibition Site

(February 2005)



Japan Association for the 2005 World Exposition

Japan Association for the 2005 World Exposition (hereinafter referred to as the Association) hereby stipulates rules, in compliance with Article 18 of the Special Regulations No. 10 concerning general services, for activities and objects prohibited (hereinafter referred to as "prohibited activities etc.") on the site of the 2005 World Exposition, Aichi, Japan (hereinafter referred to as "Exhibition"), so as to maintain public order and ensure visitor safety on the Exhibition Site (see "GL 10-7 Guidelines for the Security and Surveillance of Participants etc." and Attachment 1). Concrete applications of the rules are explained below.

1. Applicability of acts and objects prohibited on the Exhibition Site

The rules for prohibited activities, etc. shall be applicable to all persons on the entire Exhibition Site (including display areas).

2. Permission for the performance of prohibited acts etc.

Prohibited activities maybe executed and prohibited objects may be kept in possession, only if recognized as necessary and permitted by the Association.

Prohibited activities etc. may be "recognized as necessary and permitted by the Association" when written request for permission is submitted to the Association via the Association's Group in charge (the Official Participation Group, in cases concerning Official Participants) and the Association's related Groups, having recognized in consultation the necessity for performance of the prohibited activity or the possession object in question, grant the requested permission.

3. Request for permission to perform prohibited activities etc.

The formalities for requesting permission for the performance of prohibited activities or possession of prohibited objects shall be as follows:

(2) Timing of submission of written request for permission

A written application for permission may be submitted when the performance of the prohibited activity or the possession of the prohibited object is planned.

(3) Format of written application for permission

The format of the written application for permission to perform prohibited activities etc. shall be as shown in Attachment 2 "Request for Permission for Activities and Objects Prohibited on the Exhibition Site." The Association shall reserve the right to demand submission of supplementary information, depending on the content of the application.

Applicants whose request for permission to perform prohibited activities etc. has been granted must include this information in the Security Plan (cf. "GL 10-7 Guidelines for the Security and Surveillance of Participants) to be formulated by each Pavilion.

4. Areas in which prohibited acts etc. may be permitted

The Association may permit the performance of prohibited activities or possession of prohibited objects only within the Control Zone of the Official Participant who has requested permission.

If Official Participants request permission to perform prohibited activities etc. whose performance or possession exceeds their respective Control Zone, the Association shall determine whether or not to grant permission by comprehensively examining the necessity for said prohibited acts etc., comparing them with other events, studying the overall balance with relevant matters, the Exhibition Site condition as a whole etc.

5. Conditions for the permission to perform prohibited activities etc.

The Association may attach conditions to permission for prohibited activities etc. as deemed necessary, depending on the nature of the prohibited acts etc. in question. The Association shall reserve the right to cancel, or curtail the applicability of, already granted permission for prohibited acts etc. if the Association recognizes possible danger to visitors, other unfavorable effects of the prohibited activities, etc.

6. Regulation of prohibited acts etc. by Official Participants in their Control Zone

- Independent designation by Official Participants of prohibited activies etc. Official Participants may independently designate activities and objects prohibited in their Control Zone, as the need arises.
- (2) Notification of Official Participants' independent designation of prohibited activities etc.

Official Participants who designate independently prohibited activities etc. for their respective Control Zones must notify the Association in advance regarding such designation, via the Official Participation Group.

In such case, the Association's related Groups shall deliberate on the content of the regulations and shall request, if deemed necessary, that the concerned Official Participants modify the content of the designation so as to maintain uniformity on the Exhibition Site.

7. Performance of prohibited activities or possession of prohibited objects without permission

The Association may control or issue a warning concerning prohibited activities that are performed or objects that are possessed without permission and may ask the Security and Surveillance Officer of the concerned Official Participant to submit a written explanation of the situation.

8. Selling or distribution of bottled, canned and PET-bottled beverages etc.

In principle, bringing bottled, canned and PET-bottled beverages into the Exhibition Site (including sale of these items and free distribution of product samples on the Exhibition Site [hereinafter referred to as "selling etc."]) is prohibited, so as to prevent use of empty cans or bottles for throwing and other dangerous activities, including acts of terrorism.

However, selling etc. of bottled or canned beverages may be exceptionally permitted, if Official Participants have submitted a written request for permission in accordance with the formalities described in section 3 "Request for permission to perform prohibited activitiess etc.", if their activity contents meet the conditions given below, and if the Association recognizes that the Official Participants have a necessity to sell etc. these items and that they have sufficient measures to ensure public safety in relation to such sales etc.

(1) Official Participants may sell or distribute canned, bottled or PET-bottled beverages and the like for consumption at food and beverage facilities and

shops on the Exhibition Site, on condition that the sellers responsibly collect empty bottles and cans, so that they are not brought outside the facilities. This may be ensured either by having the purchasers consume the contents of the bottles and cans within said facilities, or by handing over the beverages etc. to the purchasers after transferring them to paper cups.

(2) Official Participants may sell or distribute canned, bottled or PET-bottled beverages and the like, as souvenirs and other takeout items, at food and beverage facilities and shops on the Exhibition Site, on condition that they responsibly package such items in a secure manner (i.e., the package bag or container opening is securely closed so that the content cannot be viewed from outside and cannot be removed easily), so as to ensure that the purchasers will not carry these items unwrapped. At the same time, the sellers shall hand the purchasers these items with a seal affixed, saying, "Do not open within the Exhibition Site." However, for sales etc. of PET-bottled beverages for consumption within the Exhibition Site, packaging is not required, provided that the sellers responsibly hand purchasers the beverages with the "authorized product identification mark" affixed to the caps of the PET bottles, so as to indicate that they are products with official permission for sale etc. in the Exhibition Site (i.e. they are not suspicious objects).

(Note) There are five colors of "authorized product identification mark" seals. The Association shall instruct Official Participants to change the seal color on an irregular basis, as part of antiterrorism measures.

If visitors possess bottled, canned or PET-bottled beverages and the like that do not meet the above conditions, the security staff shall seize these items as prohibited objects.

With regard to alcoholic beverages, it is prohibited to sell or distribute them outside restaurants or other designated areas, in a manner other than specified. It is also prohibited to drink alcohol outside restaurants, spectator seats and other designated areas. Persons found to engage in the above-mentioned prohibited activities will be given a warning by the security staff.

Attachment 1

Activities and Objects Prohibited on the Exhibition Site

In compliance with Special Regulation No. 10 concerning General Services, Article 18, the Japan Association for the 2005 World Exposition (hereinafter referred to as the "Association") hereby stipulates activities and objects that are prohibited throughout the site of the 2005 World Exposition, Aichi, Japan (hereinafter referred to as the "Exhibition"), so as to maintain public order and visitor safety.

In addition to the prohibited activities and objects stipulated below, Participants may independently stipulate activities and objects to be prohibited in the Control Zone under their management, in consultation with the Association.

1. Activities prohibited on the Exhibition site (entire site)

Activities stipulated below shall be prohibited on the Exhibition site, unless permitted by the Association if their necessity is exceptionally acknowledged.

- O Dangerous activities
 - Occupying space with aggressiveness; intentionally causing trouble or inconvenience to others
 - Blocking or hindering passage, rendering passage dangerous
 - Carrying objects and/or engaging in activities that are likely to injure humans or damage material objects and properties
 - Dispersal of gaseous, liquid or powdery substances, or engaging in similar acts
 - Unauthorized entry into off-limit zones
 - Roller skating and the like
- O Destructive activities
 - Destroying or soiling exhibits, facilities, furniture, equipment or other materials and properties used for the Exhibition
 - Discarding paper, used materials and other forms of waste or soil outside designated areas
 - Catching, picking and/or damaging plants, insects etc.
 - Feeding, catching, hurting and/or killing birds, animals or fish
- O Prohibited use or activities
 - Use of loudspeakers, megaphones and the like
 - Demonstration or carrying of placards, banners and the like
 - Demonstration and/or distribution of posters, flyers and the like
 - Commercial activities, display of objects (including distribution of souvenirs and the like), photographing and/or recording for commercial purposes
 - Use of radio communication equipment (excluding personal cellular phones, radios and the like)

O Others

- Eating and drinking outside designated areas
- Smoking outside designated areas, activities adjudged dangerous in terms of fire prevention
- Solicitation of donations, signature collection (for petitions), conducting surveys (sampling, questionnaire etc.)
- Collective demonstrations, public assemblies, speeches and the like for the purpose of assembling and stopping passers-by
- Releasing animals
- Planting seeds
- Other activities not mentioned above that are likely to disturb public order and peace on the Exhibition site
- 2. Objects prohibited on the Exhibition site (entire site)

Objects stipulated below shall be prohibited on the Exhibition site, unless permitted by the Association if their necessity is exceptionally acknowledged.

- O Dangerous objects
 - Gunpowder and similar harmful substances likely to cause explosion, ignition, toxic gas emission or the like
 - Tear gas sprays and similar substances likely to cause injury and/or discomfort to persons
 - Fireworks, gas cylinder, exceptionally large quantities of lighters, matches or other flammable objects
 - Cutlery, including cutters, fruit knives, scissors, chisels, bodkins and the like
 - Golf clubs, baseball bats, rackets, insect nets and other similar objects that may serve as weapons
 - Objects whose possession is prohibited by law
- O Others
 - PET bottles, bottles and jars, cans and alcoholic beverages
 - Brought-in lunches (excluding lunches permitted under prescribed conditions, such as lunches brought in by kindergarten, primary or junior high school students on school excursions under instructor's supervision)
 - Animals and plants, except walking, hearing and seeing dogs
 - Radio communication equipment such as amateur radio equipment, specified low-power radio equipment and transceivers (excluding personal cellular phones and radios)
 - Placards, banners, streamers and similar objects
 - Loudspeakers, megaphones and other items likely to cause obtrusive noise
 - Roller skates, skateboards and other similar items likely to cause inconvenience to

others' passage

- Carts, exceptionally large cases and the like
- Other objects adjudged inappropriate on the Exhibition site respective to the maintenance of public order and safety
- 3. Measures concerning prohibited activities and objects
 - (1) Refusal of admission

To maintain public order and safety on the Exhibition site, the Association may refuse admission to persons found to engage in prohibited activities or possess the prohibited objects as mentioned above, or demand that such persons leave the site; the Association also reserves the right to refuse admission and demand departure of persons who:

- Attempt to bring in prohibited objects or are found to possess prohibited objects on site
- Do not observe instructions issued by the Association-related personnel as part of their legitimate duties
- Are intoxicated, are adjudged inimical to the maintenance of public order and safety on the Exhibition site because of exceptionally peculiar clothing and/or aggressive or violent behavior and speech, causing trouble and discomfort to others
- Those who attempt to enter with false admission tickets
- Others whom the Association adjudges unfavorable for Exhibition operation

(2) Measures concerning prohibited objects

- O Visitors found to possess prohibited objects detected upon entrance shall be instructed to store such objects in coin-operated lockers or other suitable places outside the Exhibition site or, depending on the nature of the objects, they will be stored in the Exhibition's security-related facilities or disposed of.
 - * Security inspection upon entrance

At the entrance gates, visitors and their belongings shall be inspected by metal detectors, and some belongings shall be opened for direct inspection; suspicious objects shall be subjected to x-ray examination.

Materials brought in by service personnel shall be subjected to similar inspection, as deemed necessary.
