EXPO2005 GUIDELINES FOR OFFICIAL PARTICIPANTS

Guidelines on the Free Use of Toll Roads

(March 2005)



Japan Association for the 2005 World Exposition

Thanks to a special provision granted by the road authorities in charge of highways in the vicinity of the site for the 2005 World Exposition, Aichi Japan, official participants to the Exhibition, when using designated sections of toll roads in line with specified procedures, are permitted to use said sections free of charge.

1. How to Use Toll Roads Free of Charge

- (1) Pre-registered vehicles used by official participants on official business are permitted to use designated sections of toll roads free of charge, so long as the driver presents the Vehicle ID Card issued by the Japan Association for the 2005 World Exposition (hereinafter referred to as "the Association") at the tollbooth and the Toll Ticket also issued by the Association.
- (2) Vehicles that have not been registered cannot benefit from this system.
- (3) Designated sections of the toll roads to which free use applies are listed in Attachment 1.
- (4) The number of Vehicle ID Cards to be issued by the Association to official participants shall be determined according to the rules given below. The number of Toll Tickets issued shall be in line with the number of Vehicle ID Cards.
 - 1) Three Vehicle ID Cards shall be issued per country/international organization, as a rule.
 - 2) One additional Card shall be issued to countries with 2 or 3 Modules (4 Cards in total).
 - 3) Two additional Cards shall be issued to countries with 4 Modules (5 Cards in total).
 - 4) Three additional Cards shall be issued to countries with 5 Modules (6 Cards in total).
- 2. Procedure
- (1) Official participants desiring to use the system should complete Attachment 2, Vehicle Registration Form for Free Toll Road Use, giving the license number(s) of their official vehicle(s), and submit the Form to the Association.
- (2) Upon receipt of the Form, the Association shall apply to the respective road authorities to obtain toll free status for the official participant that has registered their vehicles ("Registered Participant").
- (3) When approval is received from the road authorities, the Association shall issue Vehicle ID Cards and Toll Tickets to the Registered Participant.
- (4) In order to benefit from toll free status when using the relevant toll roads, the Registered Participant shall ensure that the driver of the vehicle concerned always carries the Vehicle ID Card, that the ID Card is shown at the toll gate and that the Toll Ticket is presented to the toll collector.

- (5) The deadline for submitting the Vehicle Registration Form for Free Toll Road Use shall be October 15, 2005.
- (6) If the Registered Participant must replace the registered vehicle with another, the Vehicle ID Card of the vehicle no longer used shall be returned to the Association and a new Vehicle Registration Form for Free Toll Road Use shall be submitted to the Association, giving the license number of the replacement vehicle. Because the total number of Vehicle ID Cards the Association can issue is limited, the number of vehicle change applications by each country or international organization shall be restricted to twice the number of ID Cards stipulated in 1. (4) above.
- (7) After the end of the Exhibition, or if the Registered Participant decides to stop using the system, the Vehicle ID Cards and Toll Tickets issued by the Association must be returned to the Association.

- <NB> 1. When you use any section of the toll roads other than those listed above (including entering or exiting a non-designated section after/before driving on a designated section), the appropriate toll charge from entry IC to exit IC of the non-designated section shall be payable. (No special concessions apply to such part of the journey.) Therefore, please note that you will be charged the normal toll rate for use of non-designated sections, even if a free section has also been used. You can enter or exit the listed highways toll free at any junction within the designated sections of the highways.
 - 2. When traversing a designated section of a highway, you must tender one Toll Ticket for each tollgate you go through.

Procedure for Free Toll Road Use

 The Toll Ticket shall be valid for use only by vehicles on official business for the 2005 World Exposition, Aichi Japan. The Japan Association for the 2005 World Exposition, Aichi Japan (hereinafter referred to as "the Association") shall issue Toll Tickets and Vehicle ID Cards to vehicles concerned. Validity of use shall be between February 10, 2005 and October 25, 2005. The Ticket can be used for toll-free use of the toll road sections listed in the table below. The vehicles must strictly conform to the conditions stipulated below.

Toll Tickets are valid for use on the following toll roads:

- 2. When using one of the roads listed on the Toll Ticket, the driver must do the following at the tollbooth (except at toll gates that issue entry tickets only).
 - 1) Present the designated Vehicle ID Card issued by the Association to the toll collector manning the booth.
 - 2) Present the Toll Ticket to the toll collector.
- 3. One Toll Ticket shall be used by each vehicle for each road used in accordance with the terms detailed on the Toll Ticket. (If more than one toll payment is required for one journey, one Toll Ticket shall be needed for each payment required.)
- 4. In the event of any of the circumstances described below, Toll Tickets shall be invalidated and confiscated. The regular toll shall then be payable and in some cases the issued Vehicle ID Card may be cancelled.

- a. When used to pay for driving on undesignated sections of the road (including when driving into/out of undesignated sections from designated sections);
- b. If Toll Ticket has been tampered with;
- c. If Toll Ticket is used by a vehicle not carrying the designated Vehicle ID Card;
- d. If Toll Ticket is used by a vehicle other that indicated on the designated Vehicle ID Card;
- e. If Toll Ticket becomes illegible;
- f. If Toll Ticket is used in any way other than as indicated on Ticket and Vehicle ID Card;
- g. If Toll Ticket is used in violation of rules of these guidelines
- h. Any other illegitimate use
- 5. Under no circumstance shall Toll Tickets be reissued.
- 6. Toll Tickets cannot be used in conjunction with the ETC system.
- 7. Toll Tickets that have expired or are no longer required shall be returned to the Association without delay.
- 8. Use of Toll Tickets may be prohibited, if the respective road authority deems it necessary for operational reasons.
- 9. If special reasons arise, the respective road authority shall be permitted to impose different terms.
